The minutes of the regular Public Meeting of the Township Council of the Township of Saddle Brook held on March 12, 2015 at 7:00 PM at the Municipal Building, 93 Market Street, Saddle Brook, NJ.

Council President Mazzer called the meeting to order.

Township Clerk called the roll:

Mayor White – present Mr. Suarez, Twp. Attorney – present Mr. Lemanowicz – Twp. Engineer - present

Council President Mazzer asked everyone to please rise for the salute to the flag.

Council President Mazzer announced that adequate notice of this meeting has been sent to all Council members by police messenger on March 6, 2015 and to all legal newspapers in accordance with the provisions of the Open Public Meetings Act, Chapter 231, P.L. 1975.

The Township Clerk announced that the public is hereby advised that any statements made during the meeting of the Township Council of the Township of Saddle Brook may not be privileged or protected and that persons or entities who take issue with such comments or are offended by same, may, and have in the past, sought legal redress through the courts.

Any member of the public who addresses the Council speaks for themselves and not for the Council.

Council President Mazzer turned the floor over to Mayor White for presentations.

Mayor White said this evening they would be recognizing five very special women from the community for National Women's History Month. He explained the history of Women's History Month and said Saddle Brook has celebrated this since the early 1980s.

He acknowledged Ms. Deborah Gross-Quatrone in the category of Government Leadership and briefly discussed her accomplishments culminating in her appointment as Superior Court Judge.

He also acknowledged Ms. Diane Bonner in the category of Community Service for her work with Saddle Brook Recreation Basketball and Softball and scheduling of all events at Veterans' Field.

Next Mayor White invited Ms. Nancy Gara to the podium to receive the award for Outstanding Citizenship as a founding member of St. Philip the Apostle Church and member of the Senior Advisory Board as well as driving seniors to appointments and events. He said she looks and acts like she's 29, but it's actually the reverse.

He then read a proclamation acknowledging Ms. Gara's life and accomplishments.

Ms. Gara spoke briefly and said she has lived in Saddle Brook for 67 years and expressed her pride in the community. She said she was awed and bewildered and humbled by the honor.

Mayor White then acknowledged Ms. Cathy loele who began her educational career at Long Memorial School and worked in the school district for over 40 years. He said she was always very supportive, caring and compassionate to the children. He discussed Ms. loele's accomplishments and read a proclamation honoring her in the category of Educational Excellence.

Ms. loele accepted the proclamation and discussed her love of working in the Saddle Brook School system. She thanked her co-workers and Mr. Lo Dico for making her work life easier. She expressed her love for Saddle Brook and her pride in the community.

Mayor White next acknowledged Ms. Preeti Sherawat, owner of the Saddle Brook and Elmwood Park 7-11s. He discussed her achievements and her contributions to various Saddle Brook organizations and read a proclamation honoring her for Business Leadership.

Ms. Sherawat spoke briefly about her love for Saddle Brook and thanked everyone.

Mayor White next introduced Ms. Rose Tabito, newly appointed prosecutor in the Saddle Brook Municipal Court. He listed Ms. Tabito's awards and accomplishments. Ms. Tabito thanked everyone and said she intended to do a great job for Saddle Brook.

Mayor White then introduced Ms. Gloria Oh, newly appointed public defender for the Saddle Brook Municipal Court. He listed her accomplishments, and Ms. Oh thanked everyone and spoke about coming to work in Saddle Brook.

Council President Mazzer congratulated all of the honorees and read a brief statement about the life of Angelina Cimiluca, Councilman Cimiluca's mother, who recently passed away. Council President Mazzer extended her sympathy to Councilman Cimiluca and his family.

Council President Mazzer then congratulated the Saddle Brook Spirit Leaders who won their national championship in Hershey, Pennsylvania over the weekend and added that the seniors were crowned as grand champs.

Mayor White asked for a short recess, and Council President Mazzer agreed.

On returning from recess Council President Mazzer asked for a motion to open the meeting to the public.

Motion: Councilwoman D'Arminio Second: Councilman Camilleri

Councilman Cimiluca – yes Councilman Camilleri – yes Councilwoman D'Arminio – yes Councilman Accomando – yes Council President Mazzer - yes

Mr. Ken Sullivan of 620 North Midland Avenue read a letter from himself to the Councilmembers:

At the December 4th Township Council Meeting, resolution #12 authorization to waive ordinance regulating the start time of construction at the self service facility to be built at 635 North Midland Avenue, resolution [CR# 1214-258] waived the starting time in the second paragraph and added Saturday construction. I would appreciate a Council review of Saddle Brook's noise ordinance #133-7 Construction and Demolition, which prohibits construction on weekends and holidays. The self-storage facility is built in a residential area. It was passed by the Zoning Board in 2014. Many variances were passed by the Saddle Brook Zoning Board in order that this building be constructed in a residential area. In closing, I hope you vote no for the Saturday construction not only because I live across the street from this but because, as stated in Chapter 133 of the noise ordinance, which I guess you guys have a copy, that the Saddle Brook law should be followed.

Mr. Sullivan thanked the Council for their time.

Council President Mazzer thanked Mr. Sullivan and noted they had received his letter. She said the attorney is looking into it and they would have an answer back to him soon.

Mr. Larry Ratajczak of 92 Claremont Avenue said on Tuesday Mr. Costa, the previous engineer, was in attendance. Mr. Ratajczak said he did not believe Mr. Costa should have been carried over. His time was to December 31st and he was carried over on a project. He said: Not only did he present the plans that night or whatever drawings you had for people to look at, he expected you to absorb all of that information, make the all the decisions and everything. He's really not doing a good job, and his heart is really not in it because he's no longer our Township Engineer.

Mr. Ratajczak said he hoped he hadn't heard correctly that [Mr. Costa] had architectural fees for \$37,000 for the refreshment stand and the bathrooms. He asked if he had heard that number correctly, and Council President Mazzer said yes.

Mr. Ratajczak said: Thirty-seven thousand? What are we doing, another \$400,000 salt shed? This guy comes in here, look at his bill for the month. Sixty-six thousand dollars for the month. What did he do, the whole town? Last month was \$47,000. That's \$110,000 in two months.

Mr. Ratajczak said he didn't see any progress on anything that we're really knocking 'em dead with and finishing. Fifth Street has been ripped up for five years, Market Street is a disaster. He added: Like I said, from the Saddle Brook Diner to Elmwood Park is a one-lane road, and all you see is tail lights or brake lights, and everybody is backed up. Like I said, I'm not an engineer. I don't know, but I'm sure other things could have been done with that wasted space in the middle, but like I said, I don't know whose idea that was or how he presented it to you, but we didn't solve any problems on Market Street. It's probably worse now. It takes you longer to get to Elmwood Park now than it did prior to the traffic light. When do we say enough is enough?

Mr. Ratajczak continued: On the Zoning Board, I haven't seen him yet. I haven't seen him. If he doesn't show up, is he supposed to send a replacement or have somebody cover for him? He should have someone cover, right? If his heart's not here - I mean, he called me on two separate occasions to ask why I beat him up at the podium. This is why. Show up. I mean, you're making that money. Are you embarrassed to come here and say what you're doing? Look at the things he does with the fields. He presents you plans that night. How can you people look at the plans, read the plans and make decisions? Then he says, okay, it's going to be \$37,000 in architectural fees. Like I said, we're trying to keep costs down. I always thought the cinder block, decorative block, would be cheaper than putting tiles. I mean, did you give him a blank check book? We still don't know what this project is costing us. We have no idea. And we're going. We keep letting him talk us into... Here's what you have to understand, the more money he spends, the more money he makes. Okay? Like I told you, on the salt shed. The salt shed is \$400,000. He's going to get 10%, \$40,000 commission. We can build one for \$40. What would his commission be? Four thousand. That's why we're presented, and if we would have taken it, we would have taken it. We would have went for \$400,000. It don't matter. There's projects, like I said, that field was bolted ahead. The pump station wasn't looked at. The DPW wasn't looked at. Mr. Cimiluca makes the comment, you can't run the town like your house, but if your roof was leaking - like I said, that roof has been leaking for two years now. It doesn't take that long. I don't care how many times you want to send it out to bid. It doesn't take that long. You do the projects that you want to do, okay? And you know that was the previous administration that jammed that thing down. Same thing with Caldwell Avenue. Special meetings after special meetings, all the residents showed up. There was about a hundred people there. One person was in favor of that Caldwell Avenue project. Nobody listened to what was being said by the people. You just don't listen to what has to be done there. Like I said, it was her project, her people, and the Republicans had the majority. They jammed us. They jammed us with it.

Mr. Ratajczak discussed the TV: Lenny put a presentation on or came up to the podium on Tuesday. Like I said, he did it. He did it as a volunteer, and he did a great job, but it's like having an old car in the garage. You keep your car in the garage for twenty years, now you want to take it out. Can you use it? It's outdated.

It's antiquated. That's what our equipment is. Our equipment was in cold storage for twenty years. Now to go out and buy all new equipment, it's a big number, it's a big number. Like I said, I happen to agree with this here of using an outside company, and like I said, he made a remark, the company is from Paterson. Does it matter where they're from as long as they do the job? Lenny was a volunteer from Fair Lawn. Did we ever question is his residency? Did we ever question where he came from? We just accepted him. He came in, he did his job, did a good job and that was it. It didn't matter to us where he was from, and it shouldn't matter where this new company is from. If they're from Mars, it doesn't matter. If they do the job, they do the job. Like I said, we're just crying over spilt milk. And we should move on and go into this thing and go into it full-fledged. Like I said, we'll never know if we don't try. We're blowing money all over the place. We might as well spend some good money here. Put it on, and let people see what's going on in this town because without this TV station, nobody knows what goes on in town.

Mr. Ratajczak said: As far as the health benefits are concerned, at the previous meetings Mr. Cimiluca mentioned at least three [times] that the White Collar contract which they outline their benefits by or whatever so called, the word consecutive was removed and twenty-five years was substituted. I'm going to ask Mr. Suarez for an opinion. You can't have it both ways. If you don't make it with the consecutive years, you don't have twenty-five years. If you have twenty-five years and they're not consecutive – well. So you can't have it both ways. And we seem to be tailoring our issues here to take care of certain people, and it is what it is. Like I said, he asked us for four or five years on the benefits, no ordinance, no nothing. Now all of a sudden everybody is educated on the ordinance, that it said consecutive, the word consecutive was there. Where was that ordinance when we were asking for it? Nobody knew. It seems to me in 2011 Mr. Cimiluca tailored everything to protect himself or his benefits and left out Mr. Camilleri who was a newcomer coming in, and he can no longer get benefits or he's not entitled to them as a new Council person coming on, but Mr. Cimiluca was allowed to keep his. Like I said, I remind you, the three other candidates that ran are no longer with us because they lied to us about taking their benefits and not taking their benefits and they took them. This is the same thing. You're tailor-making something to fit your needs. Believe me, if the benefits were gone, I don't believe you would be here. Like I said, you only make it by four votes this time anyway.

Mr. Ratajczak asked Mr. Suarez through the chair if he had any opinion on that consecutive and twenty-five years yet. Mr. Suarez said: Right now that issue is being still researched. There has been, since the last meeting, documentation that has been provided to me, and I still need to review some more information, however, with certain respects, I would need to discuss some of these issues in the closed session before discussing that in the open session just because there's a number of issues that arise out of this question involving personnel, HIPAA regulations, because you have health issues that are now being addressed here and potential litigation and labor issues involving the contract which is being looked at, ordinances. The Clerk and I are going to have to get together and go over some other information that I don't have at this point. It's very complex in terms of trying to narrow things down because of some of the language and some of the issues that are now arising.

Mr. Ratajczak said: As far as labor, they are not Township employees that we're talking about. Mr. Suarez responded that elected officials are not employees, they're officials, right? But if we're looking at the labor contract, the White Collar contract, the implications could reverberate with regard to employees. That's why, like I said, there's –

Mr. Ratajczak interrupted that the White Collar union is not going to come to their defense and pick up their legal fees or stuff like that because they're not part of that union. I'm just asking. They are not part of the White Collar union, are they? Mr. Suarez said no, they are not part of the White Collar union.

Mr. Ratajczak said there was also an issue brought up about Mr. Cimiluca and Mr. Costa, their relationship. He said: Mr. Cimiluca, should he have recused himself on any of the issues when there was business being voted on and stuff like that

because he did have a business relationship with Mr. Costa? What is your opinion on that?

Through the chair, Mr. Suarez responded: Two things. I don't know all the specifics. I have not spoken with Mr. Cimiluca about what his past relationship, present, future, but I can tell you that with regard to the law as articulated through the Local Finance Board, which dispels conflicts, the law is basically that recusal is necessary when there is a conflict, which would be when there is a financial interest, a pecuniary interest, or some sort of a personal interest. So the best practice, under circumstances where there is a conflict under those three circumstances, is to recuse yourself.

Mr. Ratajczak said: Like I said, shouldn't he have told us about that or told the attorney that he did have a relationship with him? Mr. Suarez said: He and I have never spoken about that. Mr. Ratajczak said: I'm not saying you, previously, previously. Mr. Suarez said: The previous attorney. And Mr. Ratajczak said: Right, because that's when it was done. It wasn't done... Mr. Costa is not sitting here now.

Mr. Suarez said: My opinion is, as a member of the governing body, if you believe that there is one of those categories - pecuniary, personal or financial interest - that you have with regard to a specific application or a vendor, professional, etc, the best practice would be to – the Township Attorney in the Township of Saddle Brook is the ethics advisor with regard to those issues, to discuss that with the Township Attorney and then follow the advice that the Township Attorney provides to you. And in fact, there is a case involving the former Mayor of Hackensack, Jack Zisa, where in order to be protected in a situation like that, you want to get that opinion prior to voting on anything, and you want to get it in writing. There is a specific case on point in that it involved the former mayor where he cast a vote involving a piece of property that effected his personal interest, and afterwards the attorney actually said 'I gave him the advice that he could vote under those circumstances,' and the Local Finance Board said that wasn't sufficient. It has to not only be the advice of the attorney, it has to be in writing prior to actually voting on that specific issue.

Mr. Ratajczak said: So really, any project or anything that Mr. Costa gains financially, Mr. Cimiluca should not have voted on because it's benefitting Mr. Costa financially not Mr. Cimiluca, Mr. Costa is. Mr. Suarez said: I don't know what the circumstances are. If he wants to tell me, I never spoke to Mr. Cimiluca about this

Councilman Cimiluca said: I don't know where this is coming from in terms of ---. Mr. Ratajczak interrupted and said through the chair: I believe this is my time right now. Councilman Cimiluca said: You have unlimited time. You wanted unlimited time. Mr. Ratajczak said: I'm not talking to you, Andrew. I'm talking to Mr. Suarez. I have the floor! Grow up, Andrew. Don't sit up there and cry.

Councilman Cimiluca said: You're a jackass. You really are a jackass. Mr. Ratajczak said: Okay, Andrew whatever you say.

Councilman Camilleri said that's not called for. Mr. Ratajczak agreed it is not called for and added: Control yourself, Andrew.

Council President Mazzer admonished Mr. Ratajczak. Mr. Ratajczak said: Please don't interrupt me or when he does, hit the hammer. I'm right now directing my questions to Mr. Suarez.

Mr. Suarez said: I'm sorry, the last question was, should the Council person or should Mr. Costa – are you saying the Council person should recuse themselves? Mr. Ratajczak said, I know Mr. Costa is not voting. I know the Council is voting. Mr. Costa is sitting there trying to get as much work as he can and probably as much money as he can from us. As you can see in his bills, he's doing a good job, I mean on the money, not working.

Mr. Suarez said: If you have a situation where, and this is again, I don't know all the specifics with Mr. Cimiluca and Mr. Costa, I don't know when or if or how the

representation started or ended, but disclosure is always the best policy where you would disclose something, where though that person is a client of mine or not a client of mine or was a client, that's a good policy to follow. Or under circumstances because he's an attorney, and I know also as an attorney, sometimes you have an attorney-client privilege where just recusal is okay by saying 'I'm recusing myself', and you don't have to go into the fact that that's a client of mine, you can just recuse yourself and abstain. Actually it's not even an abstention, it's just a recusal on the issues involving a client say, for other issues you can disclose it, but if it's an attorney-client as an attorney, that's something that maybe the client doesn't want revealed, you would just recuse yourself and not say why you are recusing yourself. You just say 'I have a conflict and I'm recusing myself.'

Mr. Ratajczak said: But it should be on all issues. It should cover everything, right? You just don't recuse yourself today and then tomorrow you come in and they're going to vote on repaving Mayhill and who is going to be the engineer and stuff like that. You should recuse yourself from anything where he is going to get financial gain from the town. Any time he's billing out the town, he shouldn't vote on anything.

Mr. Suarez said: If you are recusing yourself on an issue, you're recused on that throughout unless and until that point where there is no more conflict. Then you don't have to be recused anymore.

Mr. Ratajczak said: You did say, as an attorney, you should know that. Mr. Suarez said: I'm saying, as an attorney, not as a Councilperson, there is like certain prohibitions and certain rights that a client would have that the client for example has the right that if they don't want you to announce that you have some sort of relationship, attorney-client because there is litigation or something along those lines out there, and if the attorney is the Council person respecting that, that's really paramount, the attorney-client privilege. Then you would just basically recuse and not say 'That's my client, I have litigation actively.'

Mr. Ratajczak said the other thing he would like to ask the council is to really seriously consider not using Mr. Costa to finish this project. He said: I don't think we're getting anything for our dollar. This gentleman here will be here with us for the next four years. Just from the way he handed the paperwork out that night and the \$37,000 bill for architectural fees, you should know where he's coming from. That field is in your hands. We can't do anything about it. You people are going to be the ones to finish it. Like I said, believe me, he's not giving you - you can see when a person is working for you and when they're not working for you, and I don't believe Mr. Costa is working, and I don't believe that he wants the job as the Zoning Board attorney because he hasn't showed up and he hasn't sent a replacement or anything like that, and Ms. Mazzer, can you please look into that and find out what the rules are of that, if he doesn't' show up? Is he supposed to show up? I know the attorney shows up, and if he doesn't, they send a sub. The engineer who previously served on the board, if he didn't show up, they sent a replacement. The planner was the only one that we said if we need you we'll let you know.

Councilman Camilleri addressed Mr. Ratajczak and said: I would like the opportunity to comment on Veterans' and try to answer one of your concerns. Bob Costa was there from the start of it, and he's just staying there to finish the project. We didn't shift gears and want to start over again, and as far as open check book he definitely doesn't have an open check book there. We are collectively, I'm not speaking for myself, but for all the Mayor and the Council, we are watching our dollars, and what's being done there.

Mr. Ratajczak asked: Do you have any idea of what he's proposing, what it's going to cost us for the bathrooms? Councilman Camilleri said no. That's out there, Larry, because we have to get the drawings. Mr. Ratajczak asked: What is he waiting for? What is he waiting for? Draw you a set of plans or sit down with him and say this is going to cost \$500,000? No Costa, we only afford three. Let's cut it back. He's putting tiles on the wall and doing everything when we're scraping. We're worried about if we can afford toilets. Yes or no?

Councilman Camilleri said: Once we get numbers that come in, we can knock stuff down. Mr. Ratajczak said: I know Mr. Cimiluca is pushing for spring sports. That's why they started in December. I think we're the only one in New Jersey that started a project like that in December, and we've gotten a lot of work in in the last six weeks.

Councilman Camilleri said for the spring sports, what was presented to us — Mr. Ratajczak interrupted that he didn't think the spring sports would be around. Councilman Camilleri said they think that mid-April the turf should go down on the field. The field, hopefully was going to be usable in mid-April. Mr. Ratajczak said: I'll tell you what, mid-April? I'll come back May 1st, and we'll see.

Mr. Len Azzarone of 34th Street in Fair Lawn identified himself as a 30-year police veteran of the Saddle Brook police department and a creator of Saddle Brook community television. He said: I didn't plan to come up here tonight. I planned to just observe, but I have to make a comment because it's a perfect example when they don't know what they're talking about is what Mr. Ratajczak just said. I only volunteered for one year, and that was for Lou D'Arminio when he was mayor. I started the television station when I was a Saddle Brook police officer and paid as a police officer, not as a TV guy. I never said anything at the caucus meeting against the gentlemen that are taping tonight. As a matter of fact, as the Mayor pointed out for anybody who is here to see by using his finger, I had said they did actually a very good job, but they should not edit the Council meeting. The video was fantastic; the video was great. That wasn't my complaint; it never was my complaint. The Council has gotten two e-mails from me. You know where I'm coming from, and I'm not going to go through it all over again. I'm talking about volunteerism, and there should be residents that are taping this and not just a paid company if possible with volunteers. I only suggested again that it's something you consider for the future and you try to make it so that the residents can do their own video and operate their own station, so we don't have to pay a vendor to do it. I agree with the Mayor 100%, that he wanted to get things on TV ASAP, and that's what he's done and he's done a good job. That wasn't my complaint; it never was. I guess Larry might have been listening - he didn't hear anything I said, so I wanted to make sure that was corrected.

Hearing no one else, Council President Mazzer asked for a motion to close the meeting to the public.

COUNCIL COMMENTS

Councilman Cimiluca referenced Mr. Sullivan's letter to the Council members. He said: In regard to that I think the ordinance that he had provided to us was just the noise ordinance, and it's my understanding that that noise ordinance may have indicated no Saturday construction. I have to say, I don't know if there's any contractor in this town that hasn't worked on a Saturday. I believe there is another ordinance that talks about the times of construction that is not in the noise ordinance. They may be inconsistent, and it's great that it was pointed out because if there is an inconsistency - we fixed that with the snow because there was an inconsistency. When we found that out, we fixed it. And we can fix this, but I do believe that there is an ordinance on the books that talks about the times of construction, and I do believe it allows Saturday construction. What we did is we just amended the Saturday construction to give them an extra hour to do this, this way they can get done faster, and it will be an overall less of an impact on the residents in that area. I asked Pete to look into that and also Mr. Suarez. In regard to that self-storage facility in that area, that I think everyone would consider it from Quik-Chek to Rosol Lane which may be a quarter mile that is all industrial or commercial. For some reason, at some point, next to Quick Chek that area was

rezoned as two-family residential. I guess for certain reasons, maybe there was a reason behind that. I'm not sure. I wasn't involved at that point, but it was rezoned from commercial or industrial to two-family houses and I have to assume that there was some kind of {inaudible} that it would be a bunch of two-family houses that were built there. That's not taking place, so my suggestion is, just like I suggested four years ago, is that we zone it correctly and we take the appropriate steps now that we know it is not going to be used as two-family houses. I think we should rezone it, make it consistent because we have Quick-Chek on the left, we have Enterprise Corrugated, we have all these industrial places, just like on Market Street. You may not remember but I brought that up years ago because Market Street is commercial on the south side, the side with the VFW. That is commercial all the way until you get to the building next to the VFW, then it becomes residential, and it's residential at that office building, the VFW, the diner and Onthe-Spot, which is just ridiculous. Why would that be residential? It's never going to be residential. So I proposed, and it was passed by the Council. Now everything on that side of the block is commercial or business. I'm going to ask that we look into doing that, this way everything is consistent. It just seems silly that there is a twofamily section there, and what that also does is that every time someone wants to do anything on that property they have to go before the boards and get all kinds of use variances, which is very difficult, and they shouldn't have to. They should just have to go for site approval.

Councilman Cimiluca said there was talk about Market Street being a mess. That's a county project. Really the County took the lead on that. We were involved mostly because we got those traffic lights in conjunction with the County, so for most of it that's all done by the County engineer. Some people think it's better. One of the reasons they have all those ins and outs is to quell traffic because otherwise it would be a four-lane speedway. That was a concern for people, and that's why that was done. Because they didn't want it to be a four-lane superhighway so you can get from Lodi to Elmwood Park really, really quick, and we did have one person, at least one person, die. That's one of the reasons that we put the lights up, to try and quell traffic because you don't want people – people are crossing the street, and you don't need to go 40 miles an hour.

Councilman Cimiluca said just to correct something about the benefits, it wasn't an ordinance with the benefits, it's the white collar contract that talks about the consecutive. Twenty was taken out, twenty-five was put in, consecutive was put in and taken out, but that's in the contract. That's not an ordinance.

Councilman Cimiluca said: In terms of recusal, I've been here for six years. I think Costa started just two years after I was elected, so four years ago. That's when I met him, actually, and I said at that time I wouldn't vote on any of his bills, and I haven't voted on any of his bills because I have done legal work for him. I have done collection work for him, meaning if someone hasn't paid him, and he wants to do something about it, I have filed lawsuits on his behalf, and I've actually been very successful in that regard. I don't feel that I can't talk about any project that he's ever been involved in. I don't feel that as a Councilman I don't think I should be shut out from that because what he's doing is something which we all wanted it done. It's a five-vote council, and usually some of the projects are brought up by the mayor. So I'm just one vote, and that vote generally is to see if a project is done. I don't believe that - if you go way out on limb, you can say well, he's benefitting from that project, but I don't vote to pay his bills. He doesn't get paid unless the Council says he gets paid, and I have never voted to pay his bills. To say that there was no disclosure, that was said I don't know how many times, twenty, thirty times. In the beginning, I said why I was abstaining on all those votes and then after a while it was just an abstention, or I said abstention for the reasons that were put forth on the record. So it's no secret. It was never a secret to Mr. Chewcaskie. Mr. Rodriguez brought it up at the last meeting, and I said if there is a legal opinion and I can sit down with Mr. Suarez, I do collection work for him and I file lawsuits, and I have recently actually today filed two. I hadn't filed one in three years. What I did was a set it aside, and other people were doing his work. He's not in, he asked me to do it, I did it. We all have to make a living, and that's what I've done. Certainly after Mr. Rodriguez had said that, I'm not the one who's going to give the opinion, and I will abide by whatever the town attorney's opinion is with regards to that. If the opinion is any project that Costa is involved in - whenever

they talk about repaving of a road I have to walk out of the Council meeting, then I'll do that. I'll go with your decision, Anthony.

Councilman Cimiluca said he appreciated Council President Mazzer acknowledging his mother, and he thanked Mayor White and Chief Kugler and Sheriff Saudino and Chief Menda and Brian Monahue of the East Rutherford police force and Lt. Di Rienzo of the Bergen County Police force and Chief Quatrone of the Lodi Police force. He said they worked it out so it was a nice procession, and I appreciate all of that. To everybody who has given their condolences I really appreciate that.

Councilman Cimiluca said he was not in on Tuesday but he commented on the abandoned property ordinance. He said he would direct this to the town attorney: I don't see that there is an enforcement clause in there, so it says what they've got to do and how much they've got to pay, but I don't see anything that says what if they don't do it. I think we may have to look at that to maybe shore that up. Maybe you can give your opinion as to whether we need that in there.

Councilman Cimiluca said: In the nepotism ordinance I think it gives the definition of relative, and the definition of relative only applies to Council members. I don't think that's really consistent with the rest of the ordinance. Later on in that same ordinance it talks about family members, but it doesn't give a definition of family members, so if there is going to be a definition of family – there's going to be a reference to family members, I think we've got to also define that. Again, the definition of relative seems like it only applies to the Council.

Councilman Cimiluca congratulated the spirit leaders and Janine Costanzo, who's youngest child is graduating, so she will no longer be involved in that. He said she's done a great job and he knew how time consuming and difficult it was to deal with a lot of different people from different areas.

Councilman Cimiluca said: Tonight we may be voting on the table of organization, and I just want to say I believe I'm going to vote in favor of it, but I just wanted to let you know that I'm not in favor, there's some talk that it's going to go from 34 to 32 total members of the police force. That was not my intention. It's not in the ordinance as it's written here, but for some reason it's out there that it's going to be 32. I will not vote for that. I don't think there's any reason to change it from 34 to 32. He referenced the chart provided by the Chief that showed four lieutenants and said that's the reason the TO is being changed for four lieutenants. There's four squads, and each squad should have a lieutenant in a perfect world. I would vote for this under the express condition that the fourth lieutenant will in fact be a squad leader and will not be doing anything else but being a squad leader, and if it happens that the fourth lieutenant is taken out of being in that position, I think that's a disservice. That's not what I expect and I don't know about the rest of the Council but we were advised that 12-hour shifts require four lieutenants and I think that lieutenant has to oversee the squad, and if he doesn't there's a problem.

Councilman Camilleri acknowledged women in history month and congratulated Deborah Gross-Quatrone, Diane Bonner, Nancy Gara, Kathy loele and Preeti Sherawat. He said they were wonderful people and loved hearing all the things they do. He then congratulated the spirit cheerleader and said it seems like year after year they acknowledge amazing things so it must be a very good program.

Councilman Camilleri said: Veterans' Field is in our lap and I just want you to be rest assured it isn't an open checkbook. We are trying to watch everything that goes on over there, and what we have to do now is do the best for Saddle Brook. I know I'm for that. I don't want to speak for everyone else in the Council, but I think collectively we are all pushing in that direction. He concluded by wishing everyone a safe and Happy St. Patrick's Day.

Councilwoman D'Arminio said she wanted to address Mr. Ratajczak as far as Mr. Costa. We do know your dislike of him, however we felt it was in the best interest of the project to keep him. That being said, there weren't plans thrown at us on Tuesday night and we agreed on them. We have been working on the plans for several weeks. We are all very serious and taking it very seriously. We haven't

decided on putting porcelain on the outside. We're still talking about things. He is in the process of getting the drawings done so he can go to bid. I would just like to tell you that we really are working diligently to move this project along.

Councilwoman D'Arminio said: As far as the ordinance for the lieutenant, I'd like to say that I am in support of the police department. I am in support of making promotions. That being said, I will be not voting for this ordinance tonight because once this promotion is made, we will have 14 supervisors for 14 patrolmen. Councilwoman D'Arminio said the mayor said a couple of weeks ago in the paper he thought we were top heavy. I think that this makes us more top heavy. I believe that we should fill the TO first, put more patrolmen on and then go forward. So therefore my vote will be no.

Councilwoman D'Arminio also congratulated all of the honorees.

Councilman Accomando congratulated all the honorees and the Spirit Leaders. He said he thought they were the hardest working group in this town as far as team sports goes.

MAYOR'S COMMENTS

Mayor White said the Mayor's Youth Group works very closely with elected officials and other community leaders on various community projects and events. He said he had a meeting with the group on Saturday, February 28th which went very well and they laid the foundation for a very productive year. He said in attendance were projects and activities committee liaison Councilwoman Karen D'Arminio, committee chairman PJ Punzo, Mayor's liaison to the Youth Group Regina Barrale and Senior Youth Group Advisor Thomas van Winkle.

Mayor White added: We are re-establishing and trying to improve our community projects and activities for our community. We feel it's very important this administration. Councilwoman D'Arminio has been appointed as the Council Liaison to the Projects and Activities Committee. She has extensive experience managing and organizing Township events, and she has been volunteering her services since 1996 first as a member of the committee and then as chairwoman from 2000 to 2010. She supervised all events in town, and our goal is to make these events spectacular and memorable once again for our residents, especially our children to enjoy and appreciate.

Mayor White said regarding the FEMA meeting, the Township received a letter last month from the Bergen County Executive James Tedesco III regarding new flood hazard area maps which FEMA had released over the last year. A copy of the letter is on the Township Website and on Facebook. Mayor White said he attended the seminar on February 10th along with the Township Emergency Management coordinator and Chief of Police Robert Kugler. Some Saddle Brook property owners were in attendance and were able to check whether their properties were included in the new flood hazard area. They also had an opportunity to speak with FEMA representatives who were available to answer questions.

Mayor White said on Monday, February 23rd he attended the Open Space Grant meeting with Mr. Lo Dico. They submitted their grant application proposal. The Open Space Trust Fund is a dedicated program supporting open space acquisition. We submitted our application proposal under the county program requesting funding under the flood plain protection program to match the grant that the township has already received from the New Jersey DEP/Blue Acres. After Hurricane Irene we received that, and it's going to be used to buy out property owners who have been affected most by repeated flooding. We should find out shortly if we will be awarded a County grant.

Mayor White said on Wednesday, March 4th he attended the Community Development Grant meeting along with Councilwoman D'Arminio and community liaison Lou Verile. The Block Grant funds are provided by the US Department of Housing and Urban Development. The Township submitted two applications, one proposing storm drain repair and maintenance programs and the other in getting

the reimbursement of the salary and wages for our senior citizen center clerk position. We presented our proposal to the Central Region Community Development representatives last night and have another meeting to attend to discuss the allocation of the grant monies.

With regard to the flood committee task force Mayor White said: As you all very well know, as a community we must be more proactive in addressing our flooding problem which has had a tremendous impact on the Township and continues to affect many of our residents. It should be, in my opinion, one of our highest priorities. We must utilize a task force approach by working together with other municipalities to develop and share different ideas and strategies. This would allow for a coordinated regionalized effort to address flooding issues caused by our shared waterways. We must also continue to make necessary adjustments to infrastructure, which we have been doing such as repairing drainage Township advisory board of residents and officials to meet on a quarterly basis to discuss flooding and to work together to address these issues. I will also be asking one interested council person to be the liaison the County Flood Management Coordinator.

Mayor White said he was very happy to say that SBC-TV is up and running for our residents. We're hoping to keep the station operational and make improvements. Along with tonight's request for new equipment, we are hoping to encourage more community involvement and increase the amount and type of content. He said: I would like to offer the school district the opportunity to air their meetings as well as events such as school plays and sporting events. We would also like to get the recreation programs involved and tape and broadcast some of their games as well. I assure you, it is our goal, me and the Township Council, to make Saddle Brook Community Television the best that it can be for our community. I don't profess to have all the answers, but I feel if we work together and rebuild the station incrementally in a responsible, efficient manner we will be successful.

Mayor White apologized to Mr. Azzarone. He said: I do not recall putting my finger up, but it certainly was not my intention to intimidate you in any way. I apologize for that. This was the direction we decided, myself and the Council. I know you are not happy with the decision. It's your opinion that we're wrong, and that's your prerogative to complain about it. I believe we're doing the right thing for the community, and in essence I think we both want the same thing which is really to improve Saddle Brook Community Television. We just differ on how to get there.

Mayor White then congratulated the Saddle Brook Spirit Leaders.

Mayor White said: Regarding the 32 and 34, it wasn't my intention to push that. I didn't push it. I could have asked the Council to really seriously consider it. I didn't think it was something the Council wanted to do even though I am somewhat in favor of that. I'm looking to be more efficient. If you hear things out there, please ask me because it was not my intention to go from 34 to 32. As you said during the last meeting, if we don't get the 34, we don't get the 34. It's my prerogative to hire 34 or 32, whatever I feel is appropriate along with the Chief of Police, but we are not changing the ordinance. As far as being top heavy, and Mr. Cimiluca, your belief that we should have a fourth lieutenant as part of the patrol, I'm in agreement with you there. I think we should have. If we're going to promote four, I believe it should be because of this 12-hour shift, and I had asked the chief that same question. What are we going to do if say for example this 12-hour shift initiative which is a temporary thing at this point, what if for some reason we don't want to do it? We're entering into a memorandum of agreement, and if for any reason the town does not feel that the 12-hour shift isn't a good thing or the PBA feels it's not something they want to continue, we will stop or we'll go back to the 8-hour shifts that we currently work. I feel that as far as being too top heavy, in this case, as you said that lieutenant would be in the patrol division, would be part of the operations. It's not where that lieutenant would be put in a command level position, would be taken off of patrol and would be working a regular 8 to 4, Monday through Friday shift. When that happens, that person essentially is taken out of the operations and they're not available to rotate around the clock like all the other officers do. So the lieutenant in our police department, even though it was a ranking position, is still part of the rank and file. It's not a command level administrative position. In the

interest of fairness, Mr. Ratajczak, we did get those plans e-mailed to us a couple of days before, so we did have an opportunity to see the plans, but your point is well taken.

Council President Mazzer congratulated the chief on his newly appointed position for LEAD. It is Law Enforcement Against Drugs. We commend you and we wish you lots of good luck. I understand it's taking the place of the DARE program. It's a worthwhile program, and we're very proud to have you there.

In May 2003, the Passaic Valley Sewerage Commission (PVSC) established its Municipal Rebate Incentive Program. This program is a cooperative effort between PVSC and your Construction Code Enforcement Office to identify projects that are subject to a Connection Fee under the PVSC Rules and Regulations. Since its inception, this program has helped PVSC control the costs associated with running PVSC's facility.

During the past calendar year, PVSC has collected \$21,519.29 in Connection Fees from projects referred to PVSC's Connection Office by Saddle Brook. 

Chief Robert Kugler thanked the Council for passing the ordinance tonight. He said it's was a very important ordinance for the police department. It dates back six years we wanted this. This addition took six years. So we've been kicking the can down the road for a long time. It's the best practices today, and it's the best conditions. Conditions maybe weren't good some years back. There was distrust and undermining and a lot of things that we now forget moving forward. All things are good right now; everything is positive. This move will be positive. It will put more police officers on the street. It will increase morale in the police department. We will have more officers working allowing others to take off. For years, for years we had a lot of people take off, when they take vacation we're down to a skeleton crew. This shift, this 12-hour initiative is going to increase the manpower and put more police officers on the road, not sitting in headquarters with the chief or doing things that are not safe for the community. I want to thank you for that. It's a trial period. The Mayor and now the police department will get together and draw up an MOU for us to agree to. It will be a one-year trial period. If it doesn't work, we tweak it. If we don't want it, we abandon it. Thank you very much for allowing us the opportunity to do it. I can tell you, it's going to be a great thing for the police department and more importantly for the benefit of the community.

Chief Kugler said he wanted to comment on the LEAD program because he felt there was a lot of confusion in law enforcement and a lot of confusion among the general public. He explained the LEAD program is basically the new DARE program. The DARE program basically had a curriculum issue, and New Jersey took offense to it, took it to task, and we created our own program, Law Enforcement Against Drugs. It's a tested program. So when you hear the word LEAD, just take a stand. That's the problem. It's a brand name. When you hear that word DARE, for the most part, everybody knows what that is. It's a drug education and prevention program that the police department and the schools have a partnership in. He said he would be remiss if he didn't thank the real officers that do the program: Lt. William Haverson, Officer Jeffrey Panagia, Officer Doug Haberman and Officer Chris Stanton. They're the ones that go into the classrooms, touch base with the children and do what's right to hopefully educate them and prevent them from getting involved with drugs and dangerous behaviors. He mentioned Captain Toepert, the original officer that brought the program to the community. Officer Schroeder and Officer Lenny Azzarone who was not a DARE officer but was very instrumental in creating videos and favorable things for that program. Chief Kugler thanked all the officers who get the accolades for that program. He then congratulated the women who got the awards in history tonight.

Councilman Cimiluca wished Chief Kugler best wishes on a speedy recovery and said he looked a lot better than the last time he saw him.

Mr. Larry Ratajczak said I just want to clarify one thing about the plans that I said he gave out that night. When I seen the expressions on your faces, it was like the first time you'd seen it. It if wasn't, that's my mistake. As far as me and Mr. Costa, we go back a couple of years, and a year ago, two years ago with the Mayhill project, Mr. Costa sat there where Mr. Suarez is sitting, and he lied to this town. He lied and said that Mayhill was certified and ready —

Council President Mazzer interrupted Mr. Ratajczak and asked him to keep it to the agenda.

Mr. Ratajczak said he had to clear up. He said, I don't have a problem working with him. Like I said today, he hasn't shown up. He's called me on two occasions and said if we're going to spar every week, I thought Mr. Costa was a professional and I would run that Zoning Board as a professional. Whatever happens at the Zoning Board is business. If he doesn't like me or if I don't like him, like I said, I'm to the point in my life where I don't care who talks to me or who don't talk to me. If we have to conduct business here, we conduct it, as professionals. I think Mr. Costa has a problem and by not showing up that tells me that there is a problem. That is the reason why I wouldn't put myself in a business or relationship with somebody I

can't trust. He did lie to the Township that that road was not complete, and Mr. Lo Dico was part of that deal also and –

Council President Mazzer again interrupted Mr. Ratajczak and cautioned him that he was going off topic.

Mr. Lo Dico said he was not part of any deal. He said let's just cut that out once and for all.
