The minutes of the regular Public Meeting of the Township Council of the Township of Saddle Brook held on November 8, 2018 at 7:00 PM at the Municipal Building, 93 Market Street, Saddle Brook, NJ.

Council President Mazzer called the meeting to order.

The Township Clerk called the roll:

Councilman Cimiluca – present Councilwoman D'Arminio – present Councilman Gierek – present Councilman Accomando – present Council President Mazzer – present

Mayor White – present Mr. Suarez, Twp. Attorney – present Mr. Arango, Twp. Engineer – present

Council President Mazzer asked everyone to please rise for the salute to the flag and remain standing for a moment of silence in memory of Ed Wilczynski, owner of Ed's Tavern, Jack Noonburg, past president of the Saddle Brook Library Board and all our veterans who have served our country.

Council President Mazzer announced that adequate notice of this meeting has been sent to all Council members and to all legal newspapers in accordance with the provisions of the Open Public Meetings Act, Chapter 231, P.L. 1975.

The Township Clerk announced that the public is hereby advised that any statements made during the meeting of the Township Council of the Township of Saddle Brook may not be privileged or protected and that persons or entities who take issue with such comments or are offended by same, may, and have in the past, sought legal redress through the courts.

Any member of the public who addresses the Council speaks for themselves and not for the Council.

Presentations

Mayor White said he was proud to be here tonight to acknowledge a group of students and a very fine teacher. He said Ms. Kay Pritchard, a photography teacher at Saddle Brook High School/Middle School contacted him with an idea to display some of the students' photography at Town Hall. It's not often that the general public gets to appreciate this kind of photography and this kind of art from the students at the high school. He said I love their vision and the way they express themselves in this exhibit. The display has brought a lot of people to Town Hall to come in and look at the work of these ten talented students who are here tonight, and again I'm extremely proud of them.

The Mayor asked Ms. Kate Pritchard to please come up and accept a certificate of recognition.

Ms. Pritchard thanked everyone for attending this evening and thanked Ms. Christine Genuario for setting up the project and said she singlehandedly helped her hang the art work. She praised her students who participated and said they are extremely talented artists adding that this work represents the building, the school, the program, myself and I couldn't be more proud of you. Thank you so much for attending tonight. This is a major opportunity, and maybe there will be more art shows in the future. Thank you for all you do and for making us look good.

Mayor White presented Ms. Prichard with a certificate of recognition for the Town Hall Photography Exhibit. Ms. Pritchard then invited each of the students up to receive certificates of recognition.

Council President Mazzer congratulated the students and then asked for a motion to open the meeting to the public.

Mr. Emil Sudol of 412 van Luyn Terrace congratulated Mayor White, Councilman Accomando and Councilwoman D'Arminio on their re-election and said he was sorry our police chief was not as successful, as he felt he was the most qualified for the job.

Mr. Sudol then said we're under a flood watch again tomorrow and maybe there could be a flood commission ...could they somehow move ahead with getting that back on the role again? He said I'm a little concerned about the flooding issues in town, especially the Saddle River. One other thing I brought up at the last meeting was the two locations under the overpass on Market Street, if something can be done there to clean that up and make it look a little bit more presentable than it does and that other piece of property on Saddle River Road near the Route 80 entrance there. I know you guys kind of agreed that something should be done. I hope you consider doing something there. That's all I have to say.

Councilman Accomando addressed Mr. Sudol through the chair and said as far as the bridge goes I did receive a letter, I don't know if anyone else received it, that they're going to have a committee in regards to beautifying it and making sure it meets state standards, so we should know something within the next 30 days.

Mr. Sudol asked if that was the county or state, and Councilman Accomando said the county.

Mr. Sudol said it really does look terrible. It's dark and dirty and it kind of is one of the entrances into town. If there's something that could spruce it up, it would be great. Thanks again.

Ms. Sylvia Zottarelli of 232 Lanza Avenue apologized for only having one copy of her document and said she would pass it around. She said I am aware the date on the article is back to the 12th, not November 12th, the year 2012, but in the body of it, the conviction date was August 3rd 2009. Where I'm going with this is, I understand that the person in this article, and I'm not mentioning any names, is now coaching our rec soccer kids. I'd really like to know how this is happening.

Mr. Suarez cautioned the members of the Council not to make any comments with regards to this article because it could be an issue in terms of someone who works for the town, but we don't know enough about something, and if someone's name or something comes up under these circumstances I don't want to have anyone have any issues with regard to legal liability.

Ms. Zottarelli said if it's publicized in the paper and it's public knowledge, how can it not be commented on?

Mr. Suarez said he didn't want any defamatory or slanderous comments.

Mayor White said he wanted to comment but we're not going to mention any names. Ms. Zottarelli said she didn't mention any names.

Mayor White said this is old news. Ms. Zottarelli said 2012 is the date of the article. Three years after the incarceration...for three years. Mayor White said you're asking why he's allowed to coach. Is that what you're saying? Ms. Zottarelli said how do you pass the background check?

Mayor White said he filed an appeal. He requested to coach and basically said ahead of time, admitted that he had this in his background, and we initially said no, but then he filed an appeal, and with the appeal, we did our own investigation,

conducted that along with the police department. He received a letter of recommendation from the Chief of Police.

Ms. Zotarelli asked can he pass the fingerprint test? Honestly, can he? Mayor White said no. Ms. Zottarelli said then everything else should be immaterial. By what the rules go to coach, everything else should be immaterial if you can't pass your fingerprint test. Mayor White asked what rules are you referring to?

Ms. Zotarelli said if you cannot pass a background fingerprint check you can't coach. Those are your rules.

Mayor White said he appealed, and like I said, if you listen to what I'm saying, he had already been as a parent, he's coaching – first of all he's not coaching rec, he's coaching travel, he also...

Ms. Zottarelli said travel is not part of rec? Mayor White asked Ms. Zottarelli to let him speak. I heard you out, and I'll give you more time to talk if you want. I'll give you an exception to the three-minute rule. Basically, that's what happened here. He was given an exception because he had already been involved in the program, he got the blessing of the outgoing commissioner whom you know very well, and the incoming commissioner. Also, he received a good review by our rec director. All the parents that he was involved with as a volunteer vouched for him as well, and he got permission from the USA Soccer Club, which all coaches that coach travel have to be certified. He received certification from them. He does have to do a yearly background check to make sure by them, that's their requirement, to make sure he doesn't get arrested, or he hasn't been arrested or there's nothing further. So that's basically it. We decided that we were going to give him a chance. He also is in the process of getting it expunged. The man made a mistake. As a young man, he made a mistake. We all have people in our lives, family friends or whatever, as a young person that may have made a mistake. He's reformed. We believe he's reformed. He had not one complaint about him, not one, if anything accolades about how he coaches and the job that he does. So that's what was done. The council is aware of it. They did not make the decision. It was my decision based on my position and all these recommendations that I received, so that's it. But this is old news. Other people know this already. You decide to make it public, that's fine.

Ms. Zottarelli said I just found out. Mayor White said you could have come to me, not in a public meeting as well. I would have appreciated that, I expect a little more from a board member that knows how things work.

Ms. Zotarelli said I just want to correct you. I'm here as a resident, not as a board member. Mayor White said it doesn't matter, Sylvia. Ms. Zotarelli said it does matter because you know if I come here as a board member, it's different rules. Mayor White said all I'm saying is you know how it works, you sit up here at the Board of Education and you know how it works. So it would have been nice if you would have come to me as a resident or as a board member as well and talked to me. A lot of people have. A lot of people know. This is not a secret. There's no secret here. I don't keep secrets, it's transparency.

Ms. Zotarelli said so you pick and choose where you can go? Mayor White said we don't pick and choose. If somebody else failed a background check and they – Ms. Zotarelli said you change the rules. Mayor White said no, we don't change the rules. If somebody failed a background check and they came and said listen, and people fail background checks for numerous reasons, some of them very minor. One of them is possession of marijuana, which may be legal. So I'm just telling you. So that's it. You got everything. You want to say something else, go ahead. I'll give you a little more time.

Ms. Zotarelli said I just think it's wrong. I don't care. He could be star coach whatever, if you can't pass the background check, you shouldn't be allowed to be with our kids, and if you want to throw my board membership into it, yeah, I have to look out for our kids.

Mayor White said the investigation revealed that this person that we're speaking about was not a threat to anyone, children or anyone else. He's not a predator, he's not a sex offender or anything like that. Let's get that straight.

Hearing no one else, Council President Mazzer asked for a motion to close the meeting to the public.

Comments

Mayor White said regarding the overpass, we got a letter from the County that on Monday, December 3rd, there's a meeting with the Bergen County engineering. Apparently, they are planning on it – they've been saying they were going to do this for a long, long time, but apparently, they're going to move forward with widening the bridge. They want to make Market, Essex, Rochelle and Main, that intersection there, they want to widen it and make turn lanes. I don't know when that's going to be. We'll know more after this meeting. It may be years, it may be soon, and if it is, anything that we do underneath there other than just clean it up a little bit... I know through the Community Partnership club and Howie Weinberg, we were thinking about doing some artwork there, doing a mural or something like that, he's been working on that. I don't want to do all this work if we're going to find out that they're going to be doing construction there shortly. But we will find out. If it's going to take a long time, we're going to try to do something. We have been in touch with the state DOT on it.

Regarding road resurfacing, Mayor White said the contractor is done with the concrete work on Claremont Avenue and will begin milling next week. He will finish up Nedellec after that. They've been doing some of the concrete work there as well. We anticipate getting to Erie, Legregni and Hayes by the end of November. Let's hope so. They seem to be working at a good pace. The town engineer and DPW superintendent Bob Hicswa are in the final review phase of selecting roads for our 2019 road program.

Mayor White said senior housing is moving along nicely, the structure is going up, and we're being told that the building should be occupied by the spring of 2019. We're scheduling a meeting with Bergen County Housing and Development to discuss the application process so that we can inform those that are interested in becoming residents there. Business Administrator Lo Dico is working with FEMA on obtaining a reimbursement for the March 8th snow storm this year that was declared a state of emergency by Governor Murphy. We're looking at upwards of \$20,000 in reimbursement money.

The Mayor said resident Vince Montagna of the Marine Corps League Detachment is collecting Toys for Tots from now until December 14th. There are collection boxes at the senior center and at the police department. Through our Community Partnership and Access for All Committees we are helping collect donations of non-perishable foods and paper products for the Saddle Brook Food Pantry housed at the First Reformed Church. We have collection boxes at Town Hall, the senior center and the library. Public Service Gas & Electric has equipped telephone poles along Market Street with electric outlets to be used for holiday lighting. Councilman Cimiluca will provide further updates on this when he speaks.

Mayor White thanked UNICO and all who participated in the Street Fair, which took place on Sunday, October 7th.

He said we worked together very well with UNICO to help make this a really nice Township event. He then thanked the book workers for their efforts on Election Day.

The Mayor said the annual senior Halloween Party was held on Tuesday, October 23rd at the VFW. He thanked the vendors who donated food for the party, Frank's Pizza, Mucci's Deli, Golden Pub and Que Pasta and senior center Director Joe Lecce, Councilwoman Karen D'Arminio and secretary Christine Genuario, Howie Rofofsky and Sandy Goodwin for bus transportation. The town website and Facebook page has photos and video posted. The video is also airing on our town TV. Mayor's Youth Group members judged the Halloween Decorating Contest on Thursday, October 25th, and the winners received an acknowledgement in the mail. The winning houses were: First Place 76 Oxford, Second Place 238 Schepis, and Third Place was 122 Claremont. Photos and videos are on the Town website and video is airing on our town TV.

The Mayor said another successful trunk or treat was held on Saturday October 27th. Due to the weather we had it indoors this year, but all went well. He thanked Councilwoman Karen D'Arminio, Councilman Todd Accomando, Project and Activities chairwomen Shannon Accomando and Christine Genuario for all their help planning and organizing and added again the Township website and Facebook page has photos and videos, and there's also a video airing on our town TV.

The Mayor listed upcoming events and dates, including the Veterans' Day ceremony on Sunday, November 11th at VFW circle on Mayhill Street. Town Offices are closed on Monday, November 12th in observance of Veterans' Day. On Friday November 23rd the town Tree Lighting and Holiday Party starts at 6:00 PM at Town Hall. The party starts immediately thereafter at the Saddle Brook High School gym. Registration for the Holiday Decorating Contest begins on Monday, December 3rd. We will post updates on the town website, Facebook, our town TV, and also students will receive a flyer in their virtual backpack.

Regarding Ed Wilczyinski, Mayor White said we had a moment of silence here tonight for him. As many of you know he was the owner of Ed's Tavern. He was a member of the Saddle Brook Kiwanis Club. He was dedicated to serving Saddle Brook and was a strong believer in St. Jude's Children's Hospital, and he hosted numerous fund raisers for them and raised millions of dollars for St. Jude's. He was a Korean War veteran, played football for the US Air Force. Overall, he as a beloved member of our community who knew most everybody in town, and he will be sorely missed.

The Mayor congratulated the Girls' High School soccer team for being division champions, winning the NJIC tournament and making it into the semi-finals and state sections. It's the first team in Saddle Brook High School Girls' Soccer history to advance that far.

In conclusion, the Mayor thanked all the residents who supported Karen, Todd and himself and said both of them are great team members. He said it's a pleasure serving with them. I think we work very well together with Flo, Andrew and Dave, and we all want to continue working hard and striving to make Saddle Brook a better place to live and do business. I believe all of us here on this dais genuinely care about the residents and will always put Saddle Brook first. Happy Thanksgiving, everyone.

Councilman Accomando spoke about the UNICO Street Fair and UNICO is a great organization, and if anyone is interested in joining and being part of it, just reach out to any one of us. I believe UNICO has their own page on Facebook. The weather didn't cooperate too well for the Trunk or Treat, but I think the fact that we had it inside was even better than having it outside, so I think that maybe that's something we will continue in the future in doing. It was cleaner, it was easier and it was just almost more of a Township feeling.

Councilman Accomando thanked everyone who came out and voted in the election and said we appreciate you going out and casting your vote. Happy Thanksgiving to everyone.

Councilman Gierek mentioned the Street Fair and said the Senior Halloween party was excellent. He congratulated all the students on their projects. It's really nice to have the students here and see all the wonderful work that they're doing. He also congratulated Mayor White, Councilwoman D'Arminio and Councilman Accomando and said it's great working with you. I'm the new kid on the block, and whenever I go to any one of you, you're always offering plenty of knowledge and ready to help me, and I really appreciate that. It's been a pleasure working with you.

Councilwoman D'Arminio said likewise.

Councilman Gierek wished everyone a Happy Thanksgiving and Happy Holiday season.

Councilwoman D'Arminio thanked everyone that came out to vote and said it's truly a privilege and an honor to represent all of you again for another term and one that I personally don't take lightly. Thank you for that. I want to thank the Mayor and this Council for your support all through the last four years also. We are a great team, and I look forward to another four years. Thank you. She said Councilman Accomando and his wife did a great job with the Trunk or Treat. It was a wonderful event. I agree with you that having it inside was even better than the cars outside in the parking lot, and the parents' displays were incredible. It was amazing.

Councilman Accomando said you can't forget Christine. Councilwoman D'Arminio said Christine is there for everything, and I do appreciate Christine. Happy Thanksgiving to everybody.

Councilman Cimiluca said I have been approached by a couple of people, and they said why are you fixing concrete in the middle of the street. I thought we were just going to do the access ramps. Well, part of the paving project is that if the sidewalk is broken or missing, we're going to fix it. Curbs, not sidewalks, I'm sorry. So in the middle of the street, if you see them working on the curb, it's because the curb is damaged, and you know that if we didn't do that, after we paved the street someone would say why did you pave the street and left the curb with problems? So that's what we're doing to answer some people's questions.

Regarding the COAH settlement, Councilman Cimiluca said Anthony Suarez, our town attorney, has worked long and hard to give us the best possible result along with our planner, and I think they've done a great job. We are entering into a settlement with Fair Share Housing, and they protected our interests. It's tough dealing with COAH, but we've gotten the best possible deal that we could have gotten. Our professionals have worked long and hard on this.

Councilman Cimiluca said the art show is a great project. These pictures are professional quality, so kudos to the students and also their teacher who must be doing a good job because it's teaching them well.

Regarding the Local Freight Impact Fund, Councilman Cimiluca said they're going to give grants. If anyone is impacted locally by freight trains in Saddle Brook. We talked about this last Thursday night, and we are going to make a strong, strong presentation to them to try and get the funds here. We don't know what can be done, but something should be done because Saddle Brook is bisected by the trains, and all of us kind of agreed last week that it's getting worse in terms of when they're doing rush hour and how long it's taking. One of the most frustrating things is when we go there, the arms come down and no train comes by and you're sitting there for five or ten minutes and nothing is happening. It's the most frustrating thing in the world. One of the problems is, some people get ticked off and they start going around, and that's when accidents happen, so we are going to – through our professionals and grant writer and engineer - we are going to make a very strong presentation. We would like to try and get some money, some studies – something has to be done with that because it's very important for people in our town. I

consider it a dangerous condition because it does stop a lot of first responders from accessing half the town when those barriers are up.

Regarding the Market Street intersection, Councilman Cimiluca said I don't know if you remember, we were on TV back then too, but during the Chamberlain administration, so it's got to be over four years ago - I went down with our engineer then, and we went to a meeting to discuss this. So it's over four years, and they said we're going to have more meetings, and then they never did. Apparently they're doing something, and one of the suggestions that I made at that meeting, I said it's not going to work unless you have left turn only lanes at every leg of that four-way intersection. That seemed like a simple idea because it's really horrible there. Just so you're aware, they are planning also on just removing the bridge and replacing the entire bridge. This way they will have access for handicapped people. The Access for All Committee, that's part of what we do, so we're pushing for that. Also pedestrian or bike pathways because right now there is none, and what they're planning on doing is five lanes on Market and Essex Street, and there will be three lanes on Rochelle Ave and four lanes on the Main Street side, but every single leg of that four way intersection is going to have a left turn only lane, so I can't wait for that to happen because it will really, really help. People coming in from Lodi to make the left turn, it takes forever at a certain period of time. It's just without that left turn only lane and without the lights being signalized sequentially, it's a killer trying to get across over there.

Councilman Cimiluca added the Veterans' ceremony is going to be at the Veterans' Circle on November 11th. It's November 11th at 11 AM. So please come down and support our veterans. The VFW one of the greatest institutions in town, and they always have refreshments.

Regarding holiday lights, Councilman Cimiluca said we are going to have them. PSE&G came and put – you would think that there's electric on those poles, but they actually have to install the plugs. So we're going to have that. We're going to have two separate areas. We're going to have the Town Hall area with one set of lighting, and then we're going to do something from Westminster to Fifth. We're going to have a different set of lighting that's going in that area. A lot of people have mentioned to me, and I'm sure to other people – why don't we have this when other towns do? We do have things that other towns don't. Sometimes we don't have things that other towns do, but we're catching up on the things that we don't have. That's going to be a great addition, and hopefully they will be up and lit at the tree lighting which is going to be the Friday after Thanksgiving as well as. Come down, it's a great activity for the kids, and afterwards go to the High School.

Councilman Cimiluca said the last thing is, I've said it before, maybe the only harder thing than running for office is winning and then sitting up there, whether it's on a local level like we are, the Board of Ed or your local community or a state, county or obviously a federal level it's a whole different ball game. So people said, why don't you run for mayor? Bob White is doing a great job. There's no reason to oppose him. He's doing a great job, and we all work great together. Personally, I wish we didn't have this form of government. I wish that you could run as a person as opposed to having to pick a side - someone's waving a blue flag and someone's waving a red flag. Personally, that's my opinion because in this town at least we are not like that. We work together. I'll call out to someone for help or for advice, and they've done likewise. It doesn't matter what color we're wearing. We all work great as a team, and that's what we are because our only goal here is to help the citizens of Saddle Brook. That's it. So congratulations to the winners and condolences to those who didn't succeed, but just the fact that you put your name in there and were part of the process is great. That's part of what makes America great. We will see you at the Tree Lighting, and have a nice Thanksgiving.

Council President Mazzer congratulated the Mayor, Councilman Accomando and Councilwoman D'Arminio and said it's great working with you guys, it's a true testament of how the Township feels – you had no opposition because you're doing such a great job.

Mayor White said I hope that's it. No one's crazy enough to want to run, I think.

Council President Mazzer congratulated the new Board of Ed members Mr. Quinn, Mrs. Ianiello and Michelle Roloff and everybody else that ran also. I congratulate you, and we appreciate coming forward to actually run for any office. It's never an easy thing, that's for sure, and also for serving. We do appreciate it. I'm very proud to live in this town. We were just talking about the organizations, how everyone comes together and we work – we may not always agree on everything, but we will work together as a team. And it shows.

OLD BUSINESS / NEW BUSINESS

Under new business, Mr. Lo Dico mentioned the Best Practices report for the year. Each year the state of NJ requires each municipality to answer a series of questions called best practices. If we score below a certain amount, it can and it does affect the receipt of state aid for the last quarter of the year. This year we've answered 61 questions, and I'm proud to say that Saddle Brook scored 95%.

Councilman Cimiluca congratulated the Township professionals through the chair and said in looking over the Best Practices work sheet the amazing thing was we got a 95, but what they do is if you score low they withhold funding – state aid. If you get a 0 to 25, they withhold everything. But if you score up to 61% - which to me is not a heck of a lot – we're at 95. We could have been at 61, so every year we're getting better. He then asked if Mr. Lo Dico was able to find out previous scores, and Mr. Lo Dico said of the past five years this is the highest score that Saddle Brook has scored. Each year they change the questions. Sometimes they're the same, sometimes they add different questions or the number of questions can vary, but this is the highest score we've received.

Councilman Cimiluca said what you need to get to get 100% aid, you need to get 61. We got 95. So congratulations. For those who may talk about what we do and how we do it, our financials are good and the way we go about doing things, whether it's financial or administrative, 95% we can argue.

Mayor White said through the chair, Emil had mentioned about the flood committee. I really would like to see us re-establish and get that going again. It's been a while since we had a meeting, and I know Emil, in speaking to him, I think he would be a member of the community that would want to be on the committee. I know Tom Dickman, our former fire chief, has expressed a lot of interest. So if any members, council members would like to be on that committee, just let me know, and hopefully we can get that back up and running.

I too want to congratulate all the Board of Education members who won the election on Tuesday. I also want to commend those that came up short. It's very difficult to get qualified people to run for public office, especially the Board of Ed, there's no compensation there, and it's a lot more than just the two meetings a month. The people that wanted to run say oh, it's only two meetings a month – they have committees, and they're all of them are on several committees, so it's more like four or five or six meetings a month. Again, I just commend all of them and wish the committee members a lot of luck. Thank you.

Council President Mazzer said in Mr. Suarez's town they elected their first woman council member in history.

Councilman Cimiluca said through the chair that the word of the month would be respect. When you talk about how we work together, we probably all consider each other friends but it's a mutual respect, and that's really what you need in order to get things done. You can disagree, but you can disagree respectfully. When we see what's going on on a national level, people screaming and yelling at each other, people getting thrown out of press conferences and things like that, point fingers at who you think is the not respectful person, but the main thing is you get up here, you be respectful, we'll be respectful back. We'll be respectful to each other, we'll be respectful to other town officials, we'll be respectful to officials from other towns and from the county. We work well with the county. I think because there is that mutual respect that we've earned and they've earned. I want to say thank you to everyone here for being a great group and showing respect to each other.
