

Dear Resident,

Enclosed is your tax bill for 2019-2020. The bill consists of municipal, school, library and county tax levy. The municipal tax levy is the only portion controlled by your municipal government. The Township Council and I continue to make every effort for fiscal responsibility, which is reflected in this tax bill.

The Township continues to provide services you have come to expect and deserve. New this year our Recreation Director Andrew Gallo started a summer camp program. We continue to apply for grants and I am proud to announce that 2 grants were received, one in the amount of \$192,000 for Phase 2 paving of Fair Lawn Pkwy and the other for \$227,000 towards the paving of Rochelle Parkway.

This year the Council and I have been exploring the possibility of acquiring the former Home Depot property (55 Mayhill St.) for a long overdue municipal complex. All municipal offices, other than police and public works would be consolidated at the complex. It would also house the Volunteer Ambulance Corps and Hook and Ladder Fire Company. There would also be a state-of-the-art civic center with youth and adult programs and activities. At this time, we are negotiating with the property owner who would build to suit. This is major project, but be assured the council and I will review the final numbers with our financial experts to make sure the tax impact will be as minimal as possible. The Township will apply for all potential grants available to offset costs.

Our Township picnic will be held on August 24th from 12 - 4 pm at the Otto Pehle section of the County Park. All residents are invited to attend and registration will take place at the Municipal Building, the Senior Center and the Library. There will be food, desserts, games and music. This year in addition to senior transportation from the Senior Center, busing for all residents will be available from the High School parking lot. Busing will be available beginning 11:30 am - 4 pm to and from the park. Come and join us for a fun day for all ages! The rain date is Sunday August 25th. I want to thank all our sponsors for their generous donations to defray the picnic costs.

As Mayor, working with the Township Council, we pledge to do all we can to keep our town safe and welcoming to all. We especially thank the members of our Volunteer Fire Department and Ambulance Corps for keeping us safe. Please remember to give during their annual fund drives and consider joining as a volunteer. If you have received an ADVICE COPY of your property tax bill, your financial institution responsible for payment has received an electronic file. This copy is for your records only.

Your prompt payment is urged. The municipal offices are closed on Fridays through AUGUST 30, 2019. However, extended hours are from 8:00 am until 4:30 pm on Mondays, Wednesdays and Thursdays and from 8:00 am until 5:00 pm on Tuesdays for your convenience. Starting September 3, 2019 offices will be open on our normal schedule of 8:30 – 4:00 Monday through Friday.

However, please be advised that this bill has a grace period until SEPTEMBER 05, 2019. WE DO NOT ACCEPT POST MARKS. MUST BE IN THE OFFICE ON OR BEFORE SEPTEMBER 05, 2019. Consequently, the payments received in the office after the due date, would be charged INTEREST WHICH REVERTS BACK TO AUGUST 1, 2019.

As part of the Township's rolling reassessment program, we would like to remind our residents that Appraisal Systems will be in town and may be appraising your property. Please ask for identification before allowing them into your home.

olutions to Stormwater Pollution

Easy Things You Can Do Every Day To Protect Our Water

A Guide to Healthy Habits for Cleaner Water

pollution on streets, parking lots and lawns is washed by rain into storm drains, then directly to our drinking water supplies and the ocean and lakes our children play in. Fertilizer, oil, pesticides, detergents, pet waste, grass clippings: You name it and it ends up in our water.

Stormwater pollution is one of New Jersey's greatest threats to clean and plentiful water, and that's why we're all doing something about it.


By sharing the responsibility and making small, easy changes in our daily lives, we can keep common pollutants out of stormwater. It all adds up to cleaner water, and it saves the high cost of cleaning up once it's dirty.

As part of New Jersey's initiative to keep our water clean and plentiful and to meet federal requirements, many municipalities and other public agencies including

colleges and military bases must adopt ordinances or other rules prohibiting various activities that contribute to stormwater pollution. Breaking these rules can result in fines or other penalties.



As a resident, business, or other member of the New Jersey community, it is important to know these easy things you can do every day to protect our water.



- Do a soil test to see if you need a fertilizer.
- Do not apply fertilizers if heavy rain is predicted.
- Look into alternatives for pesticides.
- Maintain a small lawn and keep the rest of your property or yard in a natural state with trees and other native vegetation that requires little or no fertilizer.
- If you use fertilizers and pesticides, follow the instructions on the label on how to correctly apply it.



Make sure you properly store or discard any unused portions.

Properly use and dispose of hazardous products

- Hazardous products include some household or commercial cleaning products, lawn and garden care products, motor oil, antifreeze, and paints.
- Do not pour any hazardous products down a storm drain because storm drains are usually connected to local waterbodies and the water is not treated.

- If you have hazardous products in your home or workplace, make sure you store or dispose of them properly. Read the label for guidance.
- Use natural or less toxic alternatives when possible.
- Recycle used motor oil.
- Contact your municipality, county or facility management office for the locations of hazardous-waste disposal facilities.



Keep pollution out of storm drains

- Municipalities and many other public agencies are required to mark certain storm drain inlets with messages reminding people that storm drains are connected to local waterbodies.
- Do not let sewage or other wastes flow into a stormwater system.

Clean up after your pet

- Many municipalities and public agencies must enact and enforce local pet-waste rules.
- An example is requiring pet owners or their keepers to pick up and properly dispose of pet waste dropped on public or other people's property.
- Make sure you know your town's or agency's requirements and comply with them. It's the law. And remember to:
 - Use newspaper, bags or pooper-scoopers to pick up wastes.
 - Dispose of the wrapped pet waste in the trash or unwrapped in a toilet.
 - Never discard pet waste in a storm drain.

Don't feed wildlife

- Do not feed wildlife, such as ducks and geese, in public areas.
- Many municipalities and other public agencies must enact and enforce a rule that prohibits wildlife feeding in these areas.



Dispose of yard waste properly

- Keep leaves and grass out of storm drains.
- If your municipality or agency has yard waste collection rules, follow them.
- Use leaves and grass clippings as a resource for compost.
- Use a mulching mower that recycles grass clippings into the lawn.

Don't litter

- Place litter in trash receptacles.
- Recycle. Recycle. Recycle.
- Participate in community cleanups.

Dear Mall Operator (Business Manager, Apartment Custodian, Hotel Manager),

Please take time to go to our website-saddlebrooknj.us and our ordinance regarding pet waste, refuse containers, wildlife feeding and illicit storm water connections. The New Jersey Department of Protection (NJDEP) requires that the Township notify mall operators, apartment building custodians and commercial/industrial facilities that ordinances are available and that by abiding by the laws and NJDEP regulations, we can all do our part to reduce potential impacts of stormwater discharges on the Saddle River and environment in general. The Saddle River is one of the cleanest of the north Jersey Watershed Rivers, but like most north Jersey watershed streams, nitrates originating from stormwater runoff (pet wastes and fertilizers) has had an impact on this precious resource. NJDEP generally recommends the following "Best Management Practices (BMPs)" to minimize potential environmental harm associated with stormwater runoff. These BMPs include:

- Sweep parking areas at least twice per year;
- Clean up all oil spillage or residuals observed on pavement surfaces as soon as possible;
- Keep trash bins secure;
- Limit the use of fertilizers and pesticides on lawn and landscaped areas, and
- · Check side-walk areas for pet waste, and
- · remove litter from storm drain outlets.

To this end, NJDEP has prepared a brochure that is attached to this letter that that identifies "Easy things You Can Do Every Day to Protect our Water." Thank you for your consideration in this matter.
