We are going to be judging for the Holiday Decorating Contest which started today. The deadline to sign up for the contest is December the 21st. I want to make everybody aware again that the voting for the referendum is Tuesday December 13th the polls will be open from 1 to 8 pm all the students will have a half day and everyone will go to their normal polling locations. COMMENTS

Mayor White – I'm not going to give a whole COVID report but I just want everybody to know that it is still spreading and we had a recent up tick in Saddle Brook so exercise caution. Stay away from people that are sick, if you have symptoms get tested, avoid crowds, wash or sanitize your hands frequently, avoid touching your face, get vaccinated and boosted if you haven't already and wear a mask if you're a high risk person.

I'm working with the business administrator and we will be meeting with department heads sometime in the near future to go over their annual budget request for 2023. We have a bond ordinance on the agenda tonight for approval and its requesting nine hundred and eighty five thousand dollars to make various public improvements one being the replacement of a floor at Engine Company #2 Fire House various other improvements the municipal buildings and property also parks and recreation facilities and the acquisition of some new additional replacement equipment and machinery for our DPW to include a new bucket loader and sewer jet vacuum machine. We do have a resolution on tonight in support of Bergen County Home Investment Partnership Grant Application for the Saddle Brook for the Willows at Saddle Brook which is an affordable housing project which will help partially fulfill our Mount Laurel obligation. The Anchor Program is a property tax relief program for those who apply and are eligible they will get fifteen hundred dollars for homeowners earning a hundred and fifty thousand or less, a thousand dollars for homeowners earning a hundred and fifty to two hundred and fifty thousand and four hundred and fifty dollars for renters earning a hundred and fifty thousand dollars or less. The deadline has been extended it is now January 31st 2023. The school referendum is Tuesday December 13th. The Board of Education is asking residents whether it can raise taxes and sell bonds to finance additional space and make critical upgrades across the district. The polls are open 1 to 8 pm. The mail in ballots went out this week so check your mailbox if you requested a mail in ballot and for more information you will go to the district website which is sbpsnj.org. We had our Holiday Tree Lighting and Party on Friday November 25th at the New Municipal Complex. After the tree lighting we moved into the new recreation center and hot chocolate and pretzels were served. There was holiday music, face painting, photos with Santa and Mrs. Claus. Olaf and the Grinch were also present for the kids. I want to thank the project activities committee Karen D'Arminio our Councilwoman, Todd and Shannon Accomando and Christine Genuario. I also want to thank Mr. Ortega and the Saddle Brook High School Middle School Band for playing songs also Pastor Wolf of the First Reformed Church for doing opening and closing prayers, our DPW and Police Department who were assigned and assisted there, members of the Volunteer Ambulance Corp and Volunteer Fire Department. The Fire Department always gives Santa and Mrs. Claus a ride into the complex. A special thanks to Joe Schilp and Joan Ramsey as Santa and Mrs. Claus also Thomas Van Winkle and Tyler Pozzi for taking photos, Raphael Gonzalez of Enlacosa for videotaping and all the video is on our town cable TV station and YouTube. The photos are on the Town website and Facebook page.

The information will be posted on our website and social media page. The Mayor's Youth Group will have a holiday party on December

21st and then take a bus ride and judge the homes that are registered and the results will be posted on the Facebook page the Town website either Christmas Eve or Christmas Day and the winners will receive gifts top three. Tree decorating at Van Saun Park for Winter Wonderland tickets can be purchased for the Winter Wonderland Family Fun Event at BergenCountyWinterWonderland.com and information will also be posted on our Town Facebook page and website. Every year we decorate a tree there and that tree is a live tree with a ball that you can plant and we planted several of them and two of them have survived and two of them haven't so I'm hoping this year we'll get another one that survives.
