There's things that need to be done that I'd like to see that we're starting that we've talked about and I want to see it to its fruition. Thanks to everyone out there who put their faith in us it's a privilege and honor to represent you up here thank you.

Councilwoman Sanchez – I just want to congratulate Councilwoman Mazzer, Council President Gierek and Councilman Cimiluca on their reelection. Congratulations Councilman Gierek for becoming Council President. Councilman Accomando you did a great job last year. I look forward to working with all of you again this year and I look forward to what the New Year brings and has in store for us. They're here today and they're the ones that sacrifice when I'm at meetings and doing what I need to do for the Township so I just want say thank you and just recognize them. I also want to recognize Assemblyman Chris Tully he's a very good friend of Saddle Brook along with Senator Joe Lagana and Assemblywoman Lisa Swain. Whenever we need something we can count on them to help us here in Saddle Brook whether it's something with the parks or something with one of the overpasses in the Township they're always there answering the phone for the Mayor and any of us that call and need something. I want to just congratulate Councilwoman Mazzer, Councilman Cimiluca on their reelection it was a very interesting campaign. I also want to thank the Mayor for his support we work great as a team and we're going to continue to do that to best serve the residents of Saddle Brook and make this Township the best that it can be. We all know what's happened with property values throughout Bergen County they've especially happened here people are dying and really want to move into Saddle Brook It's a great Town. During the campaign I walked door to door I knocked on literally hundreds of house doors and I asked residents what can we do better and most of those residents were very happy with what we were doing here and it showed when it came to voting. So we're doing a lot of good things we're here to serve you we're going to continue to improve to make the Township the best it can be. Finally happy prosperous healthy New Year to all the residents thank you very much.

Mayor White – I too want to congratulate Councilwoman Mazzer, Councilman Cimiluca and Council President Gierek for their victories they worked hard they deserved to win. As Councilman Accomando said this was a difficult election there was a lot of mudslinging but we prevailed. I want to thank Councilman Accomando for being the Council President

it was a tough year to be Council President but you did a fantastic job you really did. You held your composure and you were hard when you had to be but you also allowed them to say their peace. Council President Gierek congratulations on Council President you're one of the hardest working people I know this campaign I know Councilwoman Mazzer and Councilman Cimiluca and I have spoke all your hard work you were out there really every day walking knocking on doors and doing what needed to be done so I appreciate that. It was important for me because we as a team couldn't do everything that we do which is a lot. We have a lot of accomplishments and I'll get into that in a minute but we couldn't do it without each other and we're an excellent team. We don't always agree but we'll look and listen to opposing views and we always seem to come up with what's best for Saddle Brook and that's our slogan Saddle Brook first. We always do what's right for Saddle Brook even if sometimes we might not agree we're not compromising our integrity but we're compromising sometimes our view on a certain issue here and there. I also want to thank Father Bruce before I forget for the opening prayer thank you for coming out taking time out of your busy schedule. I just want to go through some of our accomplishments that we did in 2024. I'm going to try and be guick but I think it needs to be said we need to look back at the year and then look into the future what we're hoping our goals are going to be and what we want to accomplish in 2025. Road Program we continue with our current road resurfacing we did that in 2024 and over the last since 2015 we've paved over 60 roads in Saddle Brook which is a big accomplishment. We've committed to putting money out of our Capital Budget about a million dollars or so a year to improve our roads and we're really doing a great job. Most of the roads they weren't done in a long time now they look good. We do get New Jersey Department of Transportation and Community Development funds we get that with supplements us paving these roads. We do have to allocate funds to get all the roads done in the year. I do want to mention that Public Service Electric and Gas is doing gas main replacement projects throughout the Town. I know sometimes it seems like they're out there and they're digging up a road that might have been repaved not too long ago but I just want to let everybody know that it's important that they do this because they're upgrading the gas in Town and what it does is by them upgrading it we don't have nearly as many gas leaks and the service they put in is high pressure and it can handle pretty much all the new appliances that are out there. Most importantly they're responsible if the road was paved within the last five years they have to repave the whole road if not they pave the half that they dig the trench in. So we get a lot of money back from Public Service paving the roads. Additional grant funds that we received State funds for Saddle River County Park for the pond restoration which is a million dollars which is a start because that needs to be dredged and looked at and desnagged. Federal funds for sewer and storm water drainage projects one million dollars in federal funds will be used to upgrade the Municipal Complex generator to power the entire building. We took a lot of heat for that because it's a brand new building but we do have a generator but it only powers certain sections of the building but with this new generator the whole building will be powered when there's an outage and that was a million dollars federal money. The late great Bill Pascrell was able to secure that million dollars for us. Bergen County Open Space and Community Development fund for park improvements we received more funding for that. Our Recreation is improved vastly we now do a Summer Concert Series I got to thank Councilman Cimiluca because he pushed that very hard but they were very successful. We had 4 concerts throughout the summer. We also did a month long summer camp for the children the first time. We've had like a weeklong but we did the whole month of July which was a big success. There's more civic activities at the Rec Center. We've been collaborating with the library to do arts and crafts yoga etcetera. I want to put in a plug for the library because it has improved they're now offering various programs especially for preschool children. This was big this really happened in 2023 and 2024 when we converted we actually it was the Saddle Brook Junior Wrestling Program with our help but they converted the garage space at Veterans Field into a wrestling room for their program. I want to thank former Commissioner Joe Paretti who was instrumental and really took the bull by the horns and got it done along with other coaches that volunteered their time and labor also businesses that donated building supplies. It was a great example of what can be done when we all work together and that was a big success. I'm not going to mention all of these I go it written down we continue to sponsor numerous Township events a couple of new ones Ramadan Crescent Lighting we did that last year we're going to do it again this year in February for our Muslim friends out there. We also did thanks to Councilwoman Mazzer two townwide garage sales which many of the residents really like. Shredding event we've been doing, the Holiday and Christmas Decorating Contest, the fireworks which it used to be that we got help paying for that now we pay for it all ourselves but one year we didn't do it with Covid and I tell you what there was more complaints from people about not doing the fireworks so we're not going to make that mistake again but we really couldn't gather at the time with Covid. Goals for 2025 continue with Capital Improvements use grant funds for sewer and storm water drainage improvements. We want to complete at least one park project we're leaning towards the spray park which we have about \$800,000 in grant funds for that. I just want to make sure people understand that we have grant funds available we apply for these grants we get them but the rant money that we get is not enough to complete the project so we have to use funds from our capital budget in order to do it so there's only so many things we can do. We have grant money and we have a certain amount of time to use it and we try to get everything in but we do have to allocate funds which last year was a difficult budget and this years not going to be much better but we're going to try to do everything we can. I want to encourage involvement and participation in our committees our Flood Mitigation Committee which is headed by Council President Gierek we continue to make progress and we're building our membership up. We have a few residents that come for most of the meetings. Our Community Partnership and Access For All Committees we combine them that's a fantastic committee we get a large turnout there. We lost our leader there Pastor Wolf who moved away but now our new leader is going to be Thomas Van Winkle who will do a great job as he does in everything. We want to start a new committee focusing on planting trees and ways of reducing pollution and waste like a green team. We already have a handful of residents that are supporting this cause and are willing to provide assistance. This is big redeveloping 73 and 93 Market Street the old Townhall the old Police Station and Court. We're going to sell the property and redevelop it into a ratable property much like was done by Ed's Tavern property which was turned into commercial businesses on the first floor and the second floor was apartments so that's what we're looking to do. We have done a redevelopment study we're going to put that out to developers to see if we can get anybody interested. I'm sure we will because I know myself I've received even before this redevelopment study we've had a lot of interest in developers purchasing the property. Public safety the Police Department will be fully staffed in 2025 so we now have enough officers to patrol the streets that's our main priority. We want to implement more community policing projects programs like Coffee With a Cop, National Night Out things of that nature we want to get the police more involved directly with the community. We want to get the Police Department accredited again we were once we let it lapse unfortunately. We have a new Chief and a Command Staff now and we received grant funds to do the accreditation. We're also allowed to use forfeiture funds which between the two will probably cover the entire cost of getting accredited. We want to explore installing a Townwide video camera system which is very expensive but that's something that we're looking into. We want to help the Fire Department and the Ambulance Corps recruit more volunteers, provide necessary equipment and continue applying for grant money. I want to commend both the Fire Department and the Ambulance Corps and their personnel for the service they give our community. The Ambulance Corps is one of the only free squads that are left in Bergen County. I also want to thank the Bergen County Ambulance Service which supplements our team and together they make the majority of the calls and they fulfill the EMS mission here in Saddle Brook which wasn't looking so good back in the beginning of 2023 and really the end of 2023. I didn't know where it was going to go but they banded together and with assistance again from the County they're making the majority of calls which is a huge savings for the Town. I want to continue working with the school district improving communication and keeping each other informed collaborating in areas of concern especially school safety, maintaining building and grounds and maintaining a safe environment for the students and the staff, utilize shared services wherever feasible. Lastly it's something that may take some people by surprise but we are going to move the Senior Center to this Municipal Complex. There's plenty of room on the Recreation Civic Center side of the complex. If we stay at 8 Caldwell Avenue where the current Senior Center is we're going to have to put a lot of money out for building renovations and upgrades. We may be able to use that property at 8 Caldwell for more affordable housing for our seniors which is something that will be a good thing because it will work towards our COAH obligation which we need to provide a certain amount of affordable housing and we're in round number four I believe and we are allowed to build more affordable senior housing which is something we really do need. I can't tell you how many residents and seniors tell me they would love to move into the current building there which is only 30 units. I also want to give my sympathies to the Cannariato family Larry the patriarch of the family passed away last week. I also want to wish everybody a happy and healthy New Year thank you.
